- b. Debtors represent a total of \$49,583.30 with:
  - a. Pakenham Silverbacks \$13,000 outstanding with debt being outstanding over two seasons.

The Chairman shared his priorities for 2020:

#### a. Return of Div 2

This will allow clubs to develop whilst taking away the stress of fielding an 11-a-side football team. It will be a 9-man development league, run in line with the Under 19 Competition. Further details about the league will be made available shortly.

#### b. Season Alignment

The season will not move. One year is not enough time to judge the success or failure of the season alignment. We need to take these upcoming months as an opportunity to assess what went wrong and right and figure out how to correct what went wrong and further develop what went right.

## c. End of Volunteerism

We need to start paying people who have skills to do the work we can't or won't. From virtual PA and to digital marketing professionals and outsourcing Emerging Programs to those with the required skills and business structure – all these strategies will allow the Board to focus on developing and driving the Strategic Agenda for Gridiron Victoria in 2020 and beyond.

#### d. Club's

Club's need to take ownership of their own failings. Club's need to be proactive in player recruitment and retention, volunteer recruitment, coaching development and financial management. Reach out for support and ask questions if you need help. The Board has no interest in seeing club's die due to financial, player or club management issues.
